LICENSE INACTIVATION FORM

Instructions

Complete this form to request to inactivate a current license. **You must complete this form for each license you wish to inactivate.** Under A.R.S. § 32-1125.01(A), a contractor may request to inactivate a current license, for a period not to exceed five years at a time, by completing this form and paying the \$50 application fee (License fees paid prior to the inactivation are not refundable).

WARNING:



- A contractor may only inactivate its license if the license is not subject to disciplinary proceedings or suspension. A.R.S. § 32-1125.01(A).
- No contractor may inactivate a license more than twice. A.R.S. § 32-1125.01(B).
- It is illegal to engage in any act of contracting using an inactive license. A.R.S. § 32-1125.01(C).
- The inactive status of a contractor's license does not bar any disciplinary action by the Registrar against that license. A.R.S. § 32-1125.01(D).



Reactivation

Under A.R.S. § 32-1125.01(B), a contractor's license which is not suspended or revoked and is inactive may be reactivated as an active license by:

- Payment of the current renewal fee;
- Thirty days' written notice to the Registrar; and
- Submitting a Reinstatement Application to the Registrar.

The license will expire at the end of the inactivation period unless:

- The license is reactivated within the initial 5-year period; or
- The contractor submits a 2nd inactivation request for an additional period not to exceed 5 years.

If a license expires, it cannot be reactivated, and the contractor must submit a new license application. *See* A.R.S. § 32-1125.01(B).
